Waiver of Liability

The Smithfield YMCA requires that all children have an examination by a licensed physician prior to participating in YMCA sponsored activities. The purpose is to discover any condition which would make it dangerous for the child to participate in strenuous YMCA sponsored activities and to protect other participants from communicable diseases.

In accordance with Section 7-6-21 of the Rhode Island General laws (entitled) "Exemption from Liability to participants in Sponsored Athletic or Sports Events, "I hereby waive any liability that the Smithfield YMCA, its officers, directors, trustees, agents, servants, or employees shall not be liable for any bodily injury incurred to my child while practicing or participating in any contest or exhibition of an athletic or sports nature sponsored by the YMCA.

I hereby give my permission for my child to participate in the full YMCA sponsored program and, to the best of my knowledge, my child has no physical conditions which will make it dangerous for him/her to participate in YMCA sponsored activities. My child has permission to be photographed when in YMCA programming and off-site field trips and other activities where the Y program may visit that are public venues. In the event that I cannot be reached in an emergency, I hereby give my permission for my child to be taken to a hospital for emergency treatment if the parent or family doctor cannot be reached.

The fees for summer camp are listed below. All camp fees **MUST** be paid in full by the Friday before the camp session begins.

All campers must be dropped off **by** 9:00 AM if they are not registered for before camp care, as late sign-ins are problematic. Day Camp Ends at 3:30 PM. Please be sure to pick your child up on time. There is a \$5.00 late charge for every 5 minutes after 3:30 pm. If your child participates in after camp care, pick-up is by 6:00 PM. Again there is a \$5.00 late charge for every 5 minutes after 6:00 pm. The YMCA will try to make contact until 6:30 PM with the parent/guardian, if we have not been able to reach the parent/guardian, the Smithfield Police Department will be notified. Please keep in mind that it is not your money that we want, rather your children to be picked up in time to allow or staff to get to their other obligations.

Dear Parents:

Thank you for choosing the Smithfield YMCA as your child's Summer Camp Destination! We are looking forward to another great summer with plenty of fun, lots of swimming, meeting new friends and staying active. Please make sure the registration packet is *completely* filled out!

Here are some answers to frequently asked questions:

What should I wear to Camp?

Campers should wear sneakers, socks, shorts and t-shirts each day. No open-toed shoes please. Also, campers should apply sun block & carry it in their bag daily.

What should I bring to Camp?

Campers should bring a water bottle, a lunch, bathing suit & towel daily, as well as, sunscreen and a hat. Campers will be both inside and outside throughout the day.

Can I bring items from home?

No, children are not allowed to bring items from home unless designated by the YMCA. This includes any electronic devices, stuffed animals or toys. Any items not allowed at camp will be confiscated and returned to the parent/guardian at the end of the camp day.

What about lunch?

Campers need to pack a cold, bag lunch daily. We do not have access to a microwave, can opener or refrigerator. The Y also collaborates with Papa Ginos Restaurant for pizza and children can pre-order lunch on certain days!

Do I need money while at camp?

No, children do not need money while at camp. Children are NOT allowed to use the vending machine unless with a parent or guardian.
